FBP24/7 Community Grant Request

Bolehill Improvement Group are seeking support (£250) with the hard landscaping costs required to prepare "Parkers Piece" for the installation of a Coronation bench.

FBP24/10 Community Defib - Gorsey Bank

Gorsey Bank Residents Association are considering funding the purchase and installation of a Defib and have asked for support from the Town Council - at present the Town Council fund the replacement pads/batteries for community defibs e.g Bolehill, WW Memorial Bowls Club.

REC that council support this defib in the same manner as other community defibs (replacement batteries and pads). However support for further installations of Defibs by community groups will be assessed on strategic need of the area proposed. That a new Defib line be established in the account (2025-26) to more accurately budget for this expenditure.
