C24/86 Budget and Precept 2025-26

FBP24/50 have reviewed the projected budget, including proposed reductions in some expenditure lines to mitigate the impact of cost increases.

RESOLVED That the council increase the precept by 8.58% to £253 000. The Town Council is proposing reducing discretionary spending and also start to replenish capital reserves which have been spent on both the Meadows and repairs to Town Hall roof. The Town Council will undertake a review of the cost of maintaining its current fixed assets, to assess the longer-term viability of its buildings which represent a significant proportion of the Council's existing fixed costs.

The Clerk to draft a proposal for increased costs for occasional hire of Town/Memorial Hall and Market, to that match the % precept increase.

C24/87 Festival and Well Dressing/Carnival Support

Confirmation of the Concessional Hires provided to support these events in 2025 (in £2024 support was Festival £5375 and Carnival £257 actual - £1790 budget) in additional to grants to both groups (£1000 each in 24/25).

RESOLVED That the council agree concessionary hires to both groups with the level to increase at the same level as the percentage rise in precept (anticipated to be 8.58%). The grant has been set as part of the proposed budget – these will decrease to £500 each to both groups.

Recommendation FBP 24/53

To confirm adoption of the policy which replaces the existing Bullying and Harassment policy, to address the Town Council (employer) duty to take positive steps to prevent harassment in the workplace. That all Town Councillor and staff to receive training on the positive duty to prevent harassment in the workplace.

RESOLVED That the Council adopt the policy and that it be reviewed alongside other policies at the annual Town Council meeting.

C24/90 Remote Attendance and Proxy Voting Consultation

The Government has launched a consultation on whether the measures in place during the pandemic should be adopted to allow remote attendance and voting by Councillors at Council meetings. RESOLVED That the council respond supporting remote attendance and voting for council meetings but not proxy votes. All councillors are encouraged to individually respond to the consultation.
